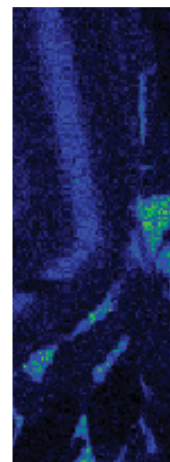
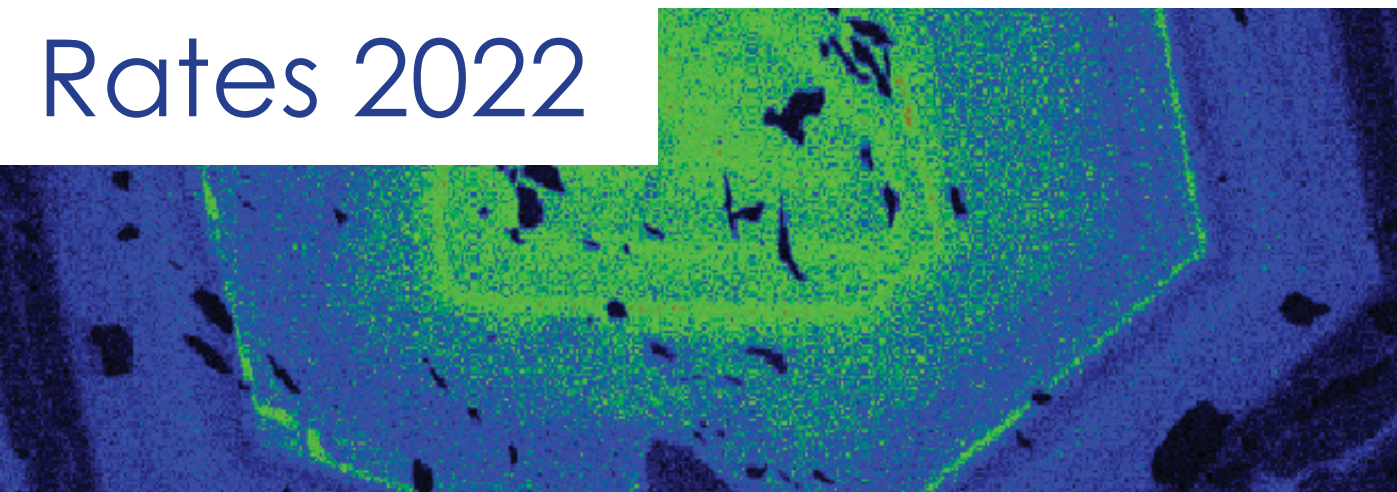


# Rates 2022



## PRINCIPLES OF THE MODEL

Instruments are grouped into Categories depending on their complexity and operating costs.

### Options:

1. Users can pay for equipment access by the hour.
2. Users can pre-pay for a block of hours in advance and receive a discounted rate.
  - The larger the block you buy, the more the discount.
  - Block hours can be used on any instrument within a category.
  - Block hours must be used by a single user (no shared blocks).
  - Block hours must be used within 12 months of purchase.
  - When you run out of hours, you can buy a new block of hours or switch to paying by the hour.

**Eligibility:** Associate rates are available to publicly funded researchers and Government organisations. This includes international researchers and WA Research Partners\*. GST will be applied if applicable.

### \*WA Research Partners

The WA Research Partner access agreement includes staff, students, adjuncts and clinical appointments from UWA, Curtin University, Murdoch University, The University of Notre Dame and Commonwealth Scientific and Industrial Research Organisation (CSIRO).

Under the access agreement, CMCA will invoice the WA Research Partners based on the Associate rate. The home institutes, through their respective Research Offices, will typically cover two-thirds of the cost, passing the remaining one-third directly onto the researcher.
